

TAX LEVY ORDINANCE
ORDINANCE NO. 2020-04

ORDINANCE OF THE BROADVIEW PUBLIC LIBRARY DISTRICT, COOK COUNTY,
ILLINOIS, LEVYING TAXES FOR THE FISCAL YEAR BEGINNING
JULY 1, 2020 AND ENDING JUNE 30, 2021

WHEREAS, applicable statutes authorize the Board of Library Trustees to levy taxes for library purposes.

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Broadview Public Library District, Cook County, Illinois, as follows:

SECTION 1: Ordinance No. 2020-02 [Budget and Appropriation Ordinance] previously passed by the Board is incorporated by reference.

SECTION 2: A tax in the sum of \$1,551,386.00 [One million five hundred fifty one thousand three hundred eighty six dollars] is levied upon all taxable property within the District, said tax levied to defray expenses and liabilities of the District for the fiscal year beginning July 1, 2020 and ending June 30, 2021 for specific objects and purposes indicated as follows:




