

TAX LEVY ORDINANCE 2023-04

ORDINANCE OF THE BROADVIEW PUBLIC LIBRARY DISTRICT, COOK COUNTY,
ILLINOIS, LEVYING TAXES FOR THE FISCAL YEAR BEGINNING
JULY 1, 2023 AND ENDING JUNE 30, 2024

WHEREAS, applicable statutes authorize the Board of Library Trustees to levy taxes for library Purposes.

NOW, THEREFORE, BE IT ORDAINED by the Board of Library Trustees of the Broadview Public Library District, Cook County, Illinois, as follows:

SECTION 1: Ordinance No. 2023-01 [Budget and Appropriations Ordinance] previously passed by the Board on July 27 th 2023 is incorporated by reference.

SECTION 2: A tax in the sum of **\$1,667,328** is levied upon all taxable property within the District, said tax levied to defray expenses and liabilities of the District for the fiscal year beginning July 1, 2023 and ending June 30, 2024 for specific objects and purposes indicated as follows:
